Since 1992, PRPHA has contracted the management of these properties with private corporations. There are currently eleven (11) Management Agents and one (1) PR Municipality managing all of PRPHA's units. Failure to meet any obligation under this Agreement shall put PRPHA's federal subsidies in immediate peril and trigger the initiation of all enforcement actions that correspondences under HUD's statuary authorities and regulations.
