#### Descripción:

The Puerto Rico Public Housing Administration (PRPHA) seeks Statement of Proposal ("SOP") from qualified individuals and/or legal entities providers, hereinafter referred to as the "Respondent", to provide MANAGEMENT AGENT SERVICES. The PRPHA is one of the nation's largest public housing authorities, which owns and operates approximately 53,757 dwelling units and other non-dwelling structures throughout the Commonwealth of Puerto Rico. It operates and manages its housing developments to provide decent, safe, sanitary and affordable housing to low income families, and implements various programs designed and funded by HUD. PRPHA reserves the right to reject any or all Proposals received and to waive any informality in the process. This procurement is totally financed with Federal Funds.
